Article 301.2 Warrant

Section II Rene has reworked the wording clarifying that the first articles on the warrant deal with town officers.

Referendums need to be decided by secret ballot.

If we have a hearing before town meeting then a referendum can be voted on in secret Consistent language will be used in 301.4 I " Any referendum shall be decided by secret ballot" 302.1 Nominations and Elections Don't use actual titles Do use language "shall be consistent with state law"

302.2 Petition I

Discussed requirements to be on the Select Board. Needs to have been a resident of Freedom for one year and a voter, qualified, (not qualified voter,) unless otherwise specified in this charter.

Question asked: do we have language in the charter that allows the town to change a position from being elected to appointed, and visa versa. It is felt the charter allows this. Need to ask if it is discriminatory to require a candidate be a registered voter, or does Freedom need to accept an unregistered voter.

A registered voter, by state law is a citizen.

III Filing and Acceptance of Petition Refer to Maine State Law

Article 303.2 Ordinances Requirements

Policy goes into effect with a Select Board vote Ordinance goes into effect with a town vote How much authority does a policy have? What is enforcement like? Do we want to keep sections I through IV? Definition of franchise discussed. It is a complicated word. At a minimum we keep sections I and III Remove "regulatory requirement" It is suggested that we discuss franchise with an attorney 303.4 Big edit 303.6 Emergency Ordinances. Keep "61st

day" language. Extensions can be made and that encourages review.

304.1 Fiscal year

The fiscal year can be changed by ordinance

304.2 Budget

The budget as presented to the town is not a line item budget.

304.11 Borrowing and Investment Guidelines there is no policy or guidelines in a manual need to state practices are consistent with state and federal law
