Article 202 Town Boards and Committees.

Section 202.1.1 Membership:

Section 202.2 Boards:

• Committee suggests putting at the beginning of the Charter Document a list of Committees, Boards, Departments, Ordinances, Policies and State Laws and where they can be found.

Section 202.3 Committees:

- Budget Committee paragraph reduced to two sentences indicating committee shall consist of at least five members with staggered terms. No alternates.
- Committee moved the appointments of a Solid Waste Representative and Broadband committee members back to Article 201 Select Board, Section 201.3.6 Appointments. To read as follows: "Required appointments for Interlocal Agreements: The Selectboard will appoint representatives to regional organizations of which the Town of Freedom is a member, for instance regional waste management, recycling, and broadband access organizations."

Article204 Administrative Organization revisited again. Section 204.2.2 Municipal Employees Handbook

- Discussed employee policies. Freedom does not have a specific handbook for employees. Policies concerning employees are part of the Select Board Policies.
- Does the MMA have a municipal employee handbook that could guide us?

Section 204.2.4 Merit Principle

• Suggested that this be moved to Article 201 Select Board, section not identified.
