8. Correspondence:

Citizens Issues:

- Patrick Terry: There are 5 maps in the Selectman's office and all of the maps show the Beaver Ridge Road. He asked the late Red Mitchell why we had so many discontinued roads and he stated that they could still be used. He is disappointed that someone would sue the town about a road. He does not feel that anyone has a right to sue the town over a road. It is a privilege to have town roads.
- This Friday is the day of court ordered mediation. It will be from 9am-2pm if needed. The goal is to find agreement.
- O Joe Freeman: asked when the town's people voted to pave the Raven Road. When will the roads be paved? Laura Greeley stated that there is a paving fund that is dedicated for the purpose of paving the roads. All of the interest from the sweep account goes into the paving account. The select board is planning for the paving by saving the money to pay for it. Lissa Widoff stated that it will be part of the Comprehensive plan as well. Joe Freeman is concerned that the town's people voted to have the road paved and it has not happened.
- Tyler Hadyniak: asked about the produced documents. He asked about an email from a potential buyer from Laura Greeley. Laura Greeley asked Cindy Abbott to send out that information to all those who had requested the FOIA. Tyler Hadyniak asked what date the recall petition was taken out. Laura Greeley suggested he email Cindy Abbott for that information.
